To: Christians, Constitutionalists, and other Pro-Lifers in South Carolina

Re: **Christian Pro-Personhood Candidate in November 8, 2016 General Election**

**United States Congress SC District #2: EDDIE McCAIN, American Party**

**[ Aiken, Barnwell, Lexington, Orangeburg (part), Richland (part) Counties ]**

On November 8, I plan to vote for Christian constitutionalist **Eddie McCain** (American Party) in his third attempt to unseat **Abortionists-Supporting** ( e.g., Planned Parenthood ), **Abortion-Supporting** ( e.g., selected surgical “abortion” and chemical “abortion” ), **Shriner, Freemason, CAFTA-supporter Globalist Joe Wilson**, the present nearly 15-year incumbent in SC’s Second Congressional District.

**Eddie McCain** [ <http://www.eddiemccain2016.com> ] has indicated he supports and will co-sponsor Federal Personhood legislation ( such as HR 426 and HR 2761 - see [www.Congress.gov](http://www.Congress.gov), which are presently active bills in the 114th United States Congress – but which have not even been given House Judiciary Subcommittee Hearings in the Republican-Majority U.S House of Representatives ! ). If there was the will in the U.S. Congress, child-murder-by-“abortion” could have been **ENDED** over 43 years ago in the entire United States by passing a Federal Personhood Bill such as HR 426 with simple majorities in both chambers and with a pro-life, pro-personhood President; or with super-majorities in both chambers without a truly pro-personhood President. And if a majority of the members of the tyrannical US Supreme Court continued to violate their Oaths of Office, and to usurp the authority of the federal legislative branch by overturning Federal Personhood legislation such as HR 426, then the U.S. Congress should pass legislation such as HR 2761 ( [www.Congress.gov](http://www.Congress.gov) ) which invokes the constitutional authority and power of the U.S. Congress under Article III, Section 2, Clause 2 of the U.S. Constitution ( [www.constitutionus.com](http://www.constitutionus.com) ), to make exceptions to the appellate jurisdiction of the U.S. Supreme Court, and to remove the matter from their judicial review on appeals. As for the lower Federal Courts, under Article 1, Section 8, Clause 9 of the U.S. Constitution, the Congress has the enumerated, delegated authority and power to not only define the complete jurisdiction of these courts ( including U.S. District Courts, and U.S. Circuit Courts of Appeal ), but whether these courts are even allowed to exist. Despite all the rhetoric we are hearing about the importance of presidential appointments to the U.S. Supreme Court ( and they are important, but they are NOT conclusively determinant ! ), we are NOT beholden to what is erroneously perceived as their power of “final arbiter” [ *sic* ] of the U.S. Constitution vis-a-vis the opinions of a majority of the lawyers in black robes on the U.S. Supreme Court, if the U.S. Congress and other civil magistrates would **DO THEIR DUTY !!!** Both the *Roe v. Wade* and *Obergefell* opinions could be undone by simple majorities in the U.S. Congress and a pro-constitution U.S. President, by invoking Article III, Section 2, Clause 2 !!!

The South Carolina Second Congressional District includes Aiken, Barnwell, Lexington, Orangeburg (part), and Richland (part) Counties. We need a Christian pro-personhood constitutionalist like Eddie McCain in the U.S. Congress, not a CAFTA-supporting Establishment water-carrier like Globalist Joe Wilson.

On November 8, if he is on your election ballot, I hope you will vote for **Eddie McCain** for U.S. Congress, Second Congressional District (SC) !
