Spoken prophetically by **VA Delegate** George Mason in 1787, the unrepented **National Sin** of **American Slavery** eventually brought **National Calamity**, at the Hand of God, in the 1861-1865 **War Between Americans** (aka War Between the States, Civil War), **killing 600,000 to 700,000 Americans**; and is still today America's most costly war in American lives lost (North and South). Christian pro-lifers who support incremental "pro-life" [*sic*] bills are unwittingly helping to lead America to more and greater Divine judgments and calamity and bloodshed if we will not Repent.

America has killed over a reported **61 MILLION children in the womb** (numberofabortions.com) since 1973; that shed innocent blood pollutes our land (Numbers 35:33, [KJV](#)), and cries out to God for justice and judgment (Genesis 4:10, [KJV](#)). God is not mocked, whatever a man, or a city, state, or nation sows, that it will also reap (Galatians 6:7, [KJV](#)). "Virginia Democrats, who control the legislature and governorship, have proposed several measures, including an "assault weapons" ban, universal background checks, and a red flag law. In response, 75 counties vowed they will not enforce future gun control legislation. Virginia Democratic Rep. Donald McEachin [told](#) the *Washington Examiner* on Thursday that Gov. Ralph Northam "may have to nationalize the National Guard to enforce the law" if local authorities refuse to do so themselves."

The president, as commander-in-chief of the armed forces, is the only person who can nationalize the Guard, but state governors have the latitude to use it to enforce state law, legal experts said.

"Until nationalized, it's a creature of the state. So that's what leads me to believe that, yes, the governor can activate the National Guard to enforce even a state law," Gary Solis, a military law professor at **[JESUIT]** Georgetown University, told the *Washington Examiner*."

The Posse Comitatus Act places [strict](#) limitations on how the military can be used to enforce the law, but the National Guard's unique status as a state unit is an exception. Many governors have activated the National Guard to enforce the law in the past.

In 1954, Arkansas Gov. Orval Faubus [directed](#) the National Guard to "preserve the public peace" by turning away black students during the court-mandated integration of Little Rock's Central High School. President Dwight Eisenhower reversed that decision by federalizing the state's entire guard, ordering it to protect the students.

National Guard units also have been mobilized during the Baltimore riots in 2015, after Hurricane Katrina devastated New Orleans in 2005, and following protests in Charlottesville in 2017.

The Virginia National Guard on Friday responded to a Democratic lawmaker after he suggested that it may be needed to enforce new gun legislation.

The remarks from Rep. A. [Donald McEachin](#) (D-Va.) suggesting that Gov. Ralph Northam (D) “may have to nationalize the National Guard to enforce the law” comes as [dozens of counties](#) across Virginia have declared themselves “Second Amendment sanctuaries” after Democrats took over the state legislature last election.

"We have received multiple questions regarding proposed legislation for the 2020 General Assembly session and the authority of the Governor of Virginia to employ the Virginia National Guard in a law enforcement role," the Virginia National Guard wrote in a statement posted on Twitter Friday.

"We understand and respect the passion people feel for the U.S. Constitution and 2nd Amendment rights. We will not speculate about the possible use of the Virginia National Guard," it added.

Northam had previously hinted that should the Democratic-controlled state legislature pass stricter gun legislation and law enforcement not follow it, there would be consequences.

"If we have constitutional laws on the books and law enforcement officers are not enforcing those laws on the books, then there are going to be some consequences," Northam said Thursday, [according to WSET](#).

"But I'll cross that bridge if and when we get to it," he added.

"Virginia representative Donald McEachin suggested Wednesday that Governor Ralph Northam may have to call out the National Guard to enforce the stricter gun laws Northam wants to pass. Northam brought up the new laws after more than 70 places in Virginia plan on declaring themselves Second Amendment Sanctuaries."

Today, the Virginia National Guard responded to both McEachin's comment and questions from Virginia's citizens.

"We have received multiple questions regarding proposed legislation for the 2020 General Assembly session and the authority of the Governor of Virginia to employ the Virginia National Guard in a law enforcement role," the Virginia National Guard tweeted on behalf of Adjutant General of Virginia Major General Timothy P. Williams.

"We understand and respect the passion people feel for the U.S. Constitution and 2nd Amendment rights," the tweet continued. "We will not speculate about the possible use of the Virginia National Guard. We have not received any requests from the Governor, or anyone on his staff, about serving in a law enforcement role related to any proposed legislation."
