Christians for Personhood scored Republican SC Senators on four 2019 SC State Budget-related votes;
publishes [Legislative Scorecard](#)

In 2019, amongst these four SC State Budget-related votes,

- 1) There were **22 out of 27 "Republican" [sic]** Senators whose votes funded selected "abortions", and;
- 2) There were **21 out of 27 "Republican" [sic]** Senators whose votes funded mass-murderers Planned Parenthood.

These are the names of the 22 out of 27 "Republican" [sic] Senators whose votes funded selected "abortions" amongst the four scored votes:

Alexander, Bennett, Campbell, Campsen, Corbin, Cromer, Davis, Gambrell, Goldfinch, Gregory, Hembree, Leatherman, Loftis, Martin, Peeler, Rankin, Senn, Shealy, Talley, Turner, Verdin, Young

Only these five did not cast votes which funded "abortions" amongst the four scored* votes:**

Cash, Climer, Grooms, Massey*, Rice**

*** Republican Senate (Republican) Majority leader **Shane Massey** is known to hold the anti-life, anti-Personhood position of opposing a ban on the murder of certain children in the womb based upon the circumstances of their conception, and in fact cast a vote on [April 17, 2019](#) (in a vote not scored in this [Legislative Scorecard](#)) indicating he is even opposed to banning *the funding* of selected "abortions" in the SC State Health Insurance Plan (PEBA/Section 108).

These are the names of the 21 out of 27 "**Republican**" Senators whose votes funded **mass-murderers Planned Parenthood** amongst the four scored votes:

Only these six did not cast votes which funded **mass-murderers Planned Parenthood** amongst the four scored votes:

Cash, Climer, Grooms, Hembree, Massey, Rice

(Not surprisingly, the voting of all 19 Democrat SC Senators amongst the four scored votes funded both selected "**abortions**", and **mass-murderers Planned Parenthood**.)

1) Proviso 33.12:

DHHS/Medicaid Hyde Amendment "Abortions"

2) Proviso 33.25

DHHS/Medicaid continued funding of mass-murderers Planned Parenthood

(Note this key proviso language: "... once the federal injunction is lifted, ...")

[The federal injunction has been in place since August 2018 - Planned Parenthood funding has continued !]

3) Proviso 108.4

PEBA/SC State Health Insurance Plan "abortions" in cases of rape, incest, and so-called "life of the mother"

IT IS NEVER NECESSARY TO INTENTIONALLY DESTROY THE UNBORN CHILD TO SAVE THE MOTHER'S LIFE; THE PROPER PROCEDURE IS TO MAKE EVERY EFFORT TO SAVE THE LIVES OF BOTH THE MOTHER AND THE CHILD, AND LEAVE THE RESULTS IN THE HANDS OF GOD, BUT NEVER, TO INTENTIONALLY KILL EITHER THE MOTHER OR THE CHILD. GOD SAYS, "THOU SHALT NOT KILL (MURDER)." EXODUS 20:13, KJV

NOTE: PREMATURE DELIVERY OF AN UNBORN CHILD TO SAVE THE MOTHER'S LIFE IS NOT AN "ABORTION". LIKEWISE, MEDICALLY NECESSARY REMOVAL OF AN ECTOPIC PREGNANCY IS NOT AN "ABORTION". IN NEITHER OF THESE TWO CASES, OR IN SIMILAR CASES, IS THE PURPOSE OF THE PROCEDURE TO INTENTIONALLY DESTROY THE UNBORN CHILD. THESE ARE NOT "ABORTIONS". UNINTENTIONAL LOSS OF THE CHILD'S LIFE IN THESE CASES MAY BE CONCOMITANT WITH A TRULY MEDICALLY NECESSARY LIFE-SAVING PROCEDURE/INTERVENTION WHOSE INTENDED PURPOSE IS NEVER THE INTENTIONAL DESTRUCTION OF THE UNBORN CHILD; HOWEVER THESE ARE NOT 'ABORTIONS'.
