One pro-life leader was ticketed (and threatened with arrest if subsequently non-compliant). Another pro-life leader who has been involved with Christian pro-life ministry at this location for over 20 years, was threatened with being ticketed if he did not leave [[Audio](#) ; later [Video](#)].*

What was Pro-"Abortion", Pro-Planned Parenthood Mayor Steve Benjamin's role in this flagrant violation of fundamental constitutional liberties ?

*The **City of Columbia** was using their [Coronavirus Stay-At-Home Order](#) to force several pro-lifers to leave the public right-of-way outside the **Planned Parenthood** killing center, violating their God-given, unalienable rights protected by law under the First Amendment to the US Constitution. These rights were violated by the **City of Columbia** on April 7, **MIS-USING** law enforcement officers and forcing these officers to break the law, and to violate citizens' fundamental constitutional rights. *This egregious violation of constitutional fundamental liberties protected under the First Amendment of the United States Constitution, as well as protected under the Constitution of the State of South Carolina, was carried out under the color of law, i.e., the **City of Columbia's** "[Stay Home Stay Safe](#)" [Emergency Order](#), the legality of which Order itself had already been seriously questioned by the Office of the Attorney General of South Carolina in a [March 27 Opinion](#) written by the Solicitor General.*

*Furthermore, the protection of [fundamental constitutional liberties](#) necessarily prevailing over the State and City Coronavirus Emergency Orders had been affirmed, respectively, 1) in a [March 24 Letter](#) from the Solicitor General, Office of the Attorney General of South Carolina, to Mark Keel, Chief of the SC Law Enforcement Division (SLED), and 2) in a March 26 Letter [included in this posted [Report](#)] from the Columbia City Attorney to Columbia Mayor **Steve Benjamin**.*

Nevertheless, despite these three documents described above:
