- **22 of 27 'Republican' [sic]** SC Senators' Votes **Funded** Selected 'Abortions'; and
- **21 of 27 'Republican' [sic]** SC Senators' Votes **Funded** Mass-Murderers Planned Parenthood;
Amongst Four 2019 State Budget Votes **Scored** by **Christians for Personhood**

That means all but **FIVE** * **Republican** SC Senators Votes **Funded** Selected 'Abortions'; and
all but **SIX** ** **Republican** SC Senators Votes **Funded** Mass-Murderers Planned Parenthood;
Amongst Four 2019 State Budget Votes **Scored** by **Christians for Personhood**.

FIVE * - Cash, Climer, Grooms, Massey, Rice
SIX ** - Cash, Climer, Grooms, Hembree, Massey, Rice

Note:

SC Senate Majority (Republican) Leader **Shane Massey** is known to hold the anti-life, anti-Personhood position of opposing a ban on the murder of certain children in the womb based upon the circumstances of their conception, and in fact cast a vote on [April 17, 2019](#) (in a vote not scored in this [Legislative Scorecard](#)) indicating he is even opposed to banning *the funding* of selected "abortions" in the SC State Health Insurance Plan (PEBA/Section 108).
