When voting on the FY 2019-2020 SC State Budget ([H.4000](#)) Democrat SC Senator Nikki Setzler repeatedly cast votes in the SC Senate in 2019 authorizing: 1) Funding for selected "abortion" through the SC State Health Insurance Plan ([Proviso 108.4](#)); 2) Funding for selected Hyde Amendment "abortion" as reflected in DHHS/Medicaid ([Proviso 33.12](#)); and 3) Funding for Planned Parenthood ([Proviso 33.25](#)). Nikki Setzler not only perpetuates "abortion" by not supporting Personhood, but 43-year incumbent Nikki Setzler also votes authorizing SC taxpayer-funding of selected "abortion" and of Planned Parenthood !!! [In Columbia alone from 1978-2019, Planned Parenthood has mass-murdered over 53,800 unborn children according to SC DHEC statistics !!!]. For his four pro-"abortion" votes on FY 2019-2020 SC State Budget, if Democrat Senators had been scored on the [2019 SC Senate Legislative Scorecard](#) [for Republican Senators], then Democrat Nikki Setzler would have received a score of 0%. Personhood opponent Senator Nikki Setzler ([District #26](#)) was NOT a co-sponsor of the 2017-2018 Personhood Bill ([S.217](#)), introduced January 10, 2017, to END "abortion" in SC. In fact, Senator Nikki Setzler has NEVER, in ANY year in which principled Personhood legislation been introduced in Senate, been a co-sponsor, since 1998 !!!

In 2018, the [S.217](#) Personhood Bill was competing for Senate Special Order with the [H.3548](#) fake "pro-life", compulsory euthanasia, incremental "abortion" regulation legislation, Dismemberment Bill. On [April 26](#), [H.3548](#) was given Rules Committee Special Order, instead of [S.217](#). Once again, as has REPEATEDLY occurred over last 22 years, Good is the Enemy of Gods Best ! Incremental Bills are the ENEMY of Personhood !

Just days later, as Senate Democrats were filibustering a Republican-supported Hyde-Amendment-type fake "pro-life" replacement amendment ([Amendment No. 18A](#), offered [May 2](#) by a leading pro-"abortion" Democrat !) to the [H.3548](#) compulsory euthanasia "Dismemberment Bill", four cloture votes were taken to end a Democrat filibuster. Although the Hyde-Amendment-type fake "pro-life" legislation did not establish Personhood, but had several exceptions, most Senate Republicans were still in favor of passage. The Republicans needed 26 votes for cloture to stop the Democrat filibuster. "Former" Democrat Senators Leatherman and Rankin were the only "Republicans" to vote "No" on the last cloture vote ([Cloture vote #4](#)) in the [May 3 Senate Journal](#), which was 25 Y to 20 N. In other words, ONLY ONE MORE "YES" VOTE was needed for cloture. SC SENATE MINORITY LEADER DEMOCRAT SENATOR NIKKI SETZLER VOTED AGAINST CLOTURE ON ALL FOUR VOTES, VOTING AGAINST ENDING THE DEMOCRAT FILIBUSTER OF A BILL THAT WAS NOT EVEN A PERSONHOOD OR TOTAL ABOLITION BILL, BUT ONE WHICH HAD MULTIPLE EXCEPTIONS.
