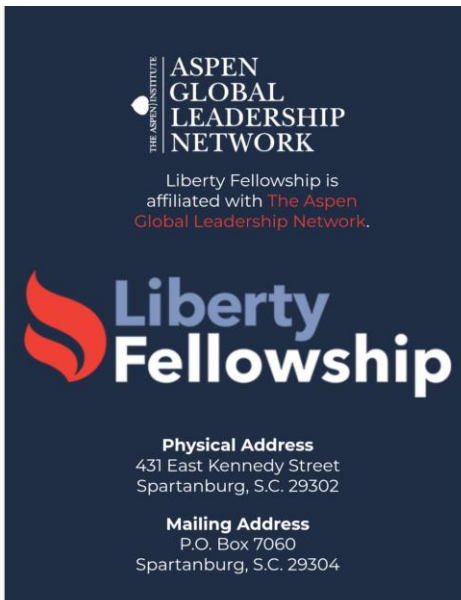

Finally, all candidates are considered in the creation of a class mosaic that reflects the rich diversity of South Carolina. ARTICLE III

LEGISLATIVE DEPARTMENT
