RINO "Republican"-majority (30R, 16D*) SC Senate **FUNDS** Baby-Killing and Baby-Killers in the SC State Budget (H5100) with funding for:

- 1) Medicaid "abortion" funding for selected "abortions" in Section 33 (DHHS)
 - As indicated in Part 1B, Proviso 33.12 (Hyde Amendment "abortions"; so-called "exceptions" *[sic]*); and,
- 2) "Family Planning Funds" going to Planned Parenthood in Section 33 (DHHS)
 - Part 1B, Proviso 33.24 (Family Planning Funds); and,
- 3) Selected "abortions" (so-called "exceptions" *[sic]*) in Section 108 (PEBA)
 - Part 1B, Proviso 108.4 (State Health Insurance Plan).
 - (Now part of SC permanent law**, defunding this "abortion" funding is more difficult.)

** Such selected "abortion"-funding in Section 108 (PEBA) was for the first time actually **codified** in permanent SC Law in the Orwellian, fake "pro-life" *[sic]*, pro-"abortion", pro-"abortion" funding "Heartbeat" Bill*** (S474) passed in May 2023.

The SC Senate passed **Section 23** of the SC State Budget H5100 (FY 2024-2025), **FUNDING** the **Medical University of South Carolina (MUSC)**, which annually commits more "abortions" than any other hospital in South Carolina (57 "abortions" in 2022****), **without** any Proviso language**** in Part 1B to prohibit such murder of human beings at MUSC. [MUSC is a South Carolina State institution.](#)

The SC Senate passed **Section 33** of the SC State Budget H5100 (FY 2024-2025), **FUNDING** the **Department of Health and Human Services (DHHS)**, with funding for **Hyde Amendment "abortions"** (so-called "exceptions" [*sic*]) as revealed by the language of Proviso 33.12, Part 1B; and with funding for "Family Planning" including for [perpetrators of mass-genocide](#) **PLANNED PARENTHOOD** in Proviso 33.24, Part 1B.

The Bill, as amended, was read the third time, passed and ordered returned to the House of Representatives with amendments.

45***** out of 46 SC State Senators voted "Aye" on one or more (in most cases, on all) of the votes above for **FUNDING**:

Each and all 45 of these SC State Senators have violated their Oath of Office (SC Const., Art. III, Sec. 26.) to "*preserve, protect and defend*" the United States Constitution, whose Preamble states:

The Preamble

We the People of the United States, in Order to form a more perfect Union, **establish Justice**, insure domestic Tranquility, provide for the common defence, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this Constitution for the United States of America. [emphasis added]

The FY 2024-2025 SC State Budget, [H5100](#) absolutely does not "establish Justice".
