On [Wednesday, May 14](#), a team of 20 Christian pro-life adults, young adults, and children traveled to Main Street, Sumter, South Carolina, with a mission of providing a Christian pro-life witness and reproof (2 Timothy 4:2, [KJV](#)) in the Sumter community to SC House Speaker Rep. [Murrell Smith, Jr.](#) (House District #67, [Map](#)), who allowed **THE ENTIRE 2025 REGULAR SESSION OF THE SC HOUSE OF REPRESENTATIVES TO TRANSPIRE** ([May 8 adjournment Sine Die](#)) while doing **EFFECTIVELY NOTHING TO STOP THE SHEDDING OF INNOCENT BLOOD BY "ABORTION" IN SOUTH CAROLINA**, despite the fact the official [SC GOP Party Platform](#)'s Right to Life plank affirms the [PERSONHOOD OF UNBORN CHILDREN](#).
