Affiant deposes as follows:

- 1. That on November 15, 2022 he was in the vicinity of the Planned Parenthood "abortion" center located in Columbia, South Carolina, and he was ultimately arrested leading to the charge in this case.
- That he was at the "abortion" center as a matter of conscience based on deeply held Christian beliefs, but also believes that based on science and law, the human beings living within the wombs of women entering the "abortion" center are natural persons*, and ought rightfully to be recognized as legal persons.

- 3. That he understands he has a constitutional right under the Fifth Amendment of the Constitution to refrain from testifying at his bench trial and that his silence could not be used against him.
- 4. That with this understanding, and considering the matter, he has decided that he will testify and explain to the judge that he was at the "abortion" center to interpose between the human beings victimized in the womb, and their oppressors planning to end their lives, even while attempts were made to verbally and/or with printed material dissuade the women from destroying the children living within their wombs. He reasonably believes children living within the wombs of their mothers are natural persons based on his information, belief, and research into the matter, and ought rightfully to be recognized as legal persons.
- 5. That he intends to testify that he believes all children living within their mothers are natural persons because science indicates human life begins at fertilization/conception, which he believes does not contradict but is consistent with God's Laws in nature and in revelation. Furthermore, he believes God's Law commands all mankind not to destroy innocent human life (Exodus 20:13, Matthew 19:18, KJV). He will also testify that based upon his information and belief, women coming into the Planned Parenthood "abortion" center on November 15, 2022 included women planning to have their child living inside their womb to be destroyed by "abortion".
