Granting [*sic* - **RECOGNIZING**] Legal Personhood and Constitutional Rights

The primary legal function of a Life at Conception Act is to grant [*sic* - **establish**] “personhood” to the fertilized egg, embryo, or fetus. This designation extends the same rights and privileges to the entity as those accorded to any born individual. The constitutional theory anchoring this movement is the **application of the Fourteenth Amendment to the preborn human being**. Granting [*sic* - **Establishing**] personhood under the Fourteenth Amendment means the entity is entitled to equal protection under the law and cannot be deprived of life without due process. This status confers legal standing, allowing the preborn entity to be represented in court and protected against actions that could end its life, thus granting [*sic* - **guaranteeing**] the entity a constitutional right to life from fertilization.

Direct Impact on Abortion Law

The most immediate consequence of granting [*sic* - **establishing] constitutional personhood from conception is the effective prohibition of abortion at all stages of pregnancy.** If a fertilized egg is legally a person with a right to life, **the state becomes constitutionally obligated to protect that life.** **This obligation overrides any privacy or autonomy rights of the pregnant person [*sic* - **woman**] regarding the termination of the pregnancy.** **Under this legal framework, performing an abortion, even early after fertilization, could be classified as homicide.** This subjects providers and potentially others involved to criminal penalties associated with **murder or negligent homicide**. States are now implementing outright bans that operate from the moment of conception. Continued...

Roe v. Wade, 410 U.S. 113 (1973)

A. The appellee and certain *amici* argue that the fetus is a "person" within the language and meaning of the Fourteenth Amendment. In support of this, they outline at length and in detail the well known facts of fetal development. If this suggestion of **personhood** is established, the appellant's case, of course, collapses,

for the fetus' right to life would then be guaranteed specifically by the Amendment. The appellant conceded as much on reargument. [Footnote 51] On the other hand, the appellee conceded on reargument [Footnote 52] that no case could be cited that holds that a fetus is a person within the meaning of the Fourteenth Amendment.

Roe v. Wade Opinion (1973):

"If this suggestion of **personhood** is established, the appellant's case [the pro-"abortion" case], of course, collapses, for the fetus' right to life would then be guaranteed specifically by the [14th] Amendment." [emphasis, comments added]

The official South Carolina Republican Party Platform is a **Personhood** platform:

THE RIGHT TO LIFE

- We believe that the right to life is the first inalienable right, without which there can be no other rights.
- We believe that all human life has intrinsic worth and should be legally protected at all stages.

Title 16 - CRIMES AND OFFENSES

**CHAPTER 3
Offenses Against the Person**

**ARTICLE 1
Homicide**

SECTION 16-3-5. Person causing injury which results in death at least three years later not to be prosecuted for homicide.

A person who causes bodily injury which results in the death of the victim is not criminally responsible for the victim's death and must not be prosecuted for a homicide offense if at least three years intervene between the injury and the death of the victim.

HISTORY: 2001 Act No. 97, SECTION 1.

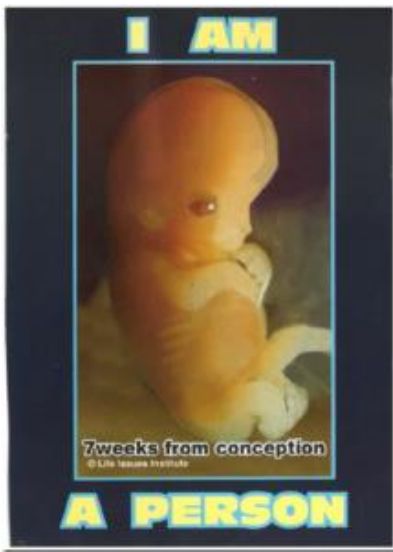
